To supply Windermere, 100% Wool carpeting, 5 metre wide, Colour: WIN-221, 42oz Felt underlay & Paperfelt Interliner to be laid beneath, Fitting to same, re-using existing gripperod fixings, Supply new gripperods to bedroom that currently has parquet flooring, Supply & fit Anodised Brass doorbars at doorways to 3 Bedrooms & Sitting Room, Seam carpet to Hallway as necessary, Existing Coir Mat & threshold bar to remain, Move furniture as necessary (**customer to move small items / personal belongings**), Uplift & dispose of existing carpets where present.

Please Note

- Our fitters do not trim doors, therefore please ensure that all doors have sufficient clearance for your chosen carpet & underlay prior to the installation. The door to the bedroom that currently has parquet flooring is currently too low.
- The beading fitted around the perimeter of the bedroom with parquet flooring will need to be removed prior to the installation.
- The provision to "move furniture" covers the movement of items of furniture that are physically too big to be moved by the occupant. Personal belongings / ornaments & small items of furniture are not included, these items should be cleared from the area to be carpeted prior to the fitter's arrival, furthermore wardrobes that require moving are to be emptied and beds that require moving should be stripped of their bedding.
