Top Bedroom, 1st Floor Front Bedroom, Stairs & Landings from Top Floor to Ground Floor

To supply Brussels 'Clearance', 100% Wool carpeting colour SPTC 0764,

Standard 8mm PU foam (bedrooms) and rubber underlay (s/landing) & Paper felt Interliner to be laid beneath,

Fitting to same by gripperods installation,

Supply & fit satin matt finish aluminum door bars,

Existing wooden threshold to remain at doorway to 1st Floor Rear Bedroom,

Move furniture as necessary (customer to move small items / personal belongings),

Stairs to be fitted full width,

Uplift & disposal of the remaining existing carpets & underlay is not included as we understand this will be done beforehand by your builder.

Fitting of Flooring = Thursday 26-08-2021

Please Note

Top Floor Bedroom Wardrobe - It is understood that a wardrobe will be built in to the top floor bedroom, this will result in the dimension from the doorway to the front of the wardrobe to be less than 4 metres so we will be able to install the carpet without a seam. **Please ensure that you advise us once this wardrobe has been installed so we can return to check measure the space, if we are not contacted to check measure the space it may result in the carpet being under sized, therefore requiring additional charges for carpet & labour in order to cover the entire area.**

Access - The winding nature of the stairs will mean that there is a possibility of the carpets marking the walls while being transported up through the property. The fitters will take utmost care in moving the materials around but please bear this point in mind as it may be necessary for these marks to be touched up after the carpets installation. Please note that Mr Carpet can not accept costs for any remedial decorative works.

Our fitters do not trim doors, therefore please ensure that all doors have sufficient clearance for your chosen carpet & underlay prior to the installation.
