Further to your recent plans submitted I have pleasure in showing the cost to supply & lay carpets as detailed below.

**Maple House, Prince Consort Drive, Ascot**

**Study, Drawing & Dining Room**

Supply & Lay Jacaranda **Rampur – 1 colour to select** 100% wool 5m wide

**Family Room, Master bedroom & dressing room. 4 further bedrooms, 1<sup>st</sup> & 2<sup>nd</sup> floor landing, annexe and annexe staircase fully fitted. Main staircase from ground to top floor with taped edges.**

Supply & Lay Bamboo Colour 870 4m wide

Supply & lay PU foam rubber underlay to all areas

Supply & fix polished aluminium door bars to all doors (except dressing rooms where we will seam doors)

Supply & Fix Smoothedge gripper fixings stuck direct to concrete subfloor

**38mm taped edges to stair runner on main stairs Faux Leather colour 11 Grey**

Labour for above installation

**Total cost labour & materials**

**£16435.00 + VAT @ 20%**

**Optional upgrade**

Supply & lay low tog underlay to all above areas

**Total cost labour & materials**

**£1510.00 + VAT @ 20%**

**IMPORTANT NOTE**

The tog value of the rubber underlay is 1.54 tog against the lower tog value underlay being only .8 tog using the std rubber underlay **may SLOW DOWN the transfer of the heat through the carpet.**

- Coir matting natural 1m or 2m wide @£20m2 **or** Colours 1m or 2m wide @£28m2

### Payment terms:

Balance due 14 days after installation

### Delivery

Allow 21 - 28 days from ordering

### Customers notes.

1. Door clearances to be satisfactory prior to our arrival.
- 2. Seams will be required to both all areas over 5m in both dimensions for Rampur areas and all areas over 4m in both dimensions for Bamboo areas**
3. Estimate based on installation in one visit to site.
4. All gripper & door bars will be stuck to concrete floor due to under floor heating and access is required 24 hours before carpet installation to allow adhesive to dry.

I trust this estimate meets with your approval and it is guaranteed for a period of 21 days from the above date. Thereafter it may be subject to change without notification if a manufacturer's price increase prevails.
