Further to your recent plans submitted I have pleasure in showing the cost to supply & lay wood flooring as detailed below.

Morningside, Warren Drive, Kingswood

Specification

Supply & apply 2 coats liquid DPM to builders finish concrete sub floor.

To Supply & lay engineered rustic Walnut multi ply single plank wood flooring to areas listed below. Board Dimensions 189mm x 1830mm x 21mm (15mm multi ply with 6mm Walnut top). Board finished in Matt Lacquer. Flooring stuck direct with flexible adhesive as required.

Perimeter expansion gaps to have a matching scotia supplied & fitted at all skirting's.

Gym - Labour & Materials

£7433.00 + VAT @ 20%

Items NOT included in above costing

- No allowance has been made for the supply & laying of latex screeding if required. This is not usually required on a newly laid concrete subfloor.
- No allowance has been made in above costing for transition bars between the wood and other floor coverings at entrances and also at fire hearths etc. **Allow a pc sum of £20.00 lin m.**
- **No allowance has been made to protect the floor after installation. The assumption is we will be laying the flooring after building works are complete.**

IMPORTANT NOTE

1. When using wood flooring over under floor heating the surface temperature should not exceed 27 degrees Celsius including under any rugs.
2. Strict temperature controls of the under floor heating before, during and immediately after installation must be followed. Please see attached instructions for heating use at these times.
3. Flooring must be acclimatised on site 3 days before installation and secure storage conditions in the areas to be fitted are required.

Payment terms:

Balance due 14 days after installation

Delivery

Allow 21 - 28 days from ordering

Customers notes.

1. Door clearances to be satisfactory prior to our arrival.
2. Estimate based on installation in one visit to site.
