Supply Cobalt 80% wool 42oz twist colour selected from samples marked "A"
Supply 42oz felt underlay
Supply Smoothedge gripper fixings
Coir matting 1m wide by depth of corridor at front door
Labour for above materials

Supply Cambridge 100% colour 90 Granite
Supply 42oz felt underlay
Supply Smoothedge gripper fixings
Coir matting 1m wide by depth of corridor at front door
Labour for above materials

Kitchen

Supply single Plank Beech Laminate (as fitted in cottage)
Supply 3mm pe foam underlay
Supply matching expansion bars at all doors & coir matting
Supply coir matting 1m wide by depth of hall at front door.
Labour for above materials

£488.00 + VAT @ 20%

No allowance in above figures for supplying & fitting of beading to cover perimeter expansion if flooring is to be fitted after skirtings.

Bathroom

Supply Vinyl flooring as per samples submitted
Fitted direct to existing subfloor
Sealed at perimeters with mastic
Labour for above materials
