

Terms & Conditions of Trading

PRICES

Prices are subject to alteration without notice and are applied at the date of despatch. Excluded from this are bona fide contract orders accepted and acknowledged by us as being at a fixed price. All customers on our current mailing list will be sent a new official Trade Price List on publication and will be deemed to have received same. **ALL PREVIOUS LISTS ARE CANCELLED.**

CLAIMS AND RETURNS

- Carpets should be inspected by dealers before cutting to close fit a room. Claims for manufacturing faults which the dealers could have discovered by a careful inspection prior to cutting cannot be accepted after a carpet has been cut and laid. No complaint can be considered which arises from improper installation.
- No other complaint can be considered until merchandise has been examined by the dealer and a report submitted on our official complaint form.
- No goods sold to dealers may be returned without written consent of the company.
- Goods returned to us for a credit because of dealers error will only be credited at the actual resale value obtained by the Company. This includes returns arising from duplication of orders due to failure of dealers to mark confirmation orders as such.
- Carpets sold as imperfect will not be considered as the subject for any complaint.
- The Company cannot accept any liability for the cost of uplifting or refitting carpet, or other types of floor-covering, in any circumstances.
- Mohawk International's liability shall be limited to replacement value of any goods agreed by Mohawk International inc. to be defective.
- Mohawk International inc. accept no liability for injury or damage to persons or property caused by carriers.
- Mohawk International inc. accept no liability for any associated costs relating to late deliveries, damaged or faulty carpet, wrong colour or size etc.

DAMAGED OR LOSS IN TRANSIT

If goods are damaged in transit the carriers note must be endorsed accordingly and the Company notified within three days of receipt of goods. The Company must also be notified if goods are not received within ten days of invoice. Failure to notify in either course will result in loss of any claim.

INSOLVENCY OF BUYER

1 This clause applies if:

- the Buyer makes any voluntary arrangement with its creditors or (being an individual or firm) becomes bankrupt or (being a company) becomes subject to an administration order or goes into liquidation (otherwise than for the purposes of amalgamation or reconstruction); or
- an encumbrancer takes possession, or a receiver is appointed, of any of the property or assets of the Buyer; or
- the Buyer ceases, or threatens to cease, to carry on business; or
- the Seller reasonably apprehends that any of the events mentioned above is about to occur in relation to the Buyer and notifies the Buyer accordingly.

SHADING

All pile carpets, especially plain grounds, are liable after they have been in use for some time, to shading, i.e. to show light and dark patches. This is due to uneven pressing of the surface by treading. Light and delicately shaded carpets are liable to become soiled in wear when it may appear that the colours have faded. The tendencies are inherent in all pile fabrics and we cannot, therefore, accept any responsibility for complaints arising from either of these causes.

PIECE LENGTHS

Roll price is only given on uncut rolls; when an exact length is specified the cut length will apply. Rolls are assumed to be over 25.00 linear metres by the width.

SIZE TOLERANCES

Whilst every effort is made to manufacture the correct size, slight variations are unavoidable therefore that the consumer be recommended to order 1% more length than required.

SPECIFICATIONS

Operating a policy of continuous improvement, we reserve the right to modify material construction and specifications without notice.

MATCHING

Request for colour matching must be specifically stated on the order otherwise no claim can be entertained.

RETENTION OF TITLE

Title to goods delivered does not pass to the purchaser until full payment has been received by us in accordance with our terms and conditions of sale.

PLACING OF ORDER

Nothing in this price list shall be deemed to constitute an offer and the Company reserves the right to refuse to accept any order. Placing of an order implies the acceptance of these terms of trading.

VALUE ADDED TAX

Prices quoted in this list do not include Value Added Tax.

TERMS OF PAYMENT

Payment is due on the 20th of the month following the date of the invoice and is subject to 2% cash discount on the net value of the goods (exclusive of VAT) if paid by the due date.

INTEREST CLAUSE

In the event of a customer failing to make payment to this Company under the terms of payment above, interest shall accrue and be paid by the purchaser on all unpaid sums and invoices at the rate of 2% above the Barclays Bank PLC base rate.

CARRIAGE

Goods delivered to dealers premises by the Company's appointed carriers are carriage paid. The costs involved for requested special deliveries will be charged.

DELIVERY

Whereas every effort is made to execute orders promptly, the Company will not accept liability for consequential loss arising from any delay. **Deliveries are all free in house for orders in excess of £150, for lesser amounts a £35 surcharge will be charged. Excluding carpet tiles and underlay.**

ACCESS TO SITE

In the event of access to the place of delivery being unobtainable the right is reserved to charge all costs incurred in the abortive visit, or any additional visit, to the customer.

CANCELLATIONS

Cancellations or alterations cannot be accepted once the carpet has been cut to dealers original specifications. Cancellations by telephone cannot be accepted unless confirmed in writing without delay. Cancellations of contract or special orders cannot be accepted after manufacture has begun.

DISPLAY

All displays are supplied free on loan and remain the property of Mohawk. In the event that you damage or dispose one of our displays without providing a ten day working window to allow for collection you will be charged the full retail price for the stand.
