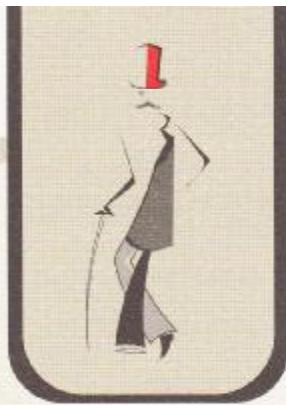

**Cut Length Orders**

Orders for cut lengths must be for a minimum of 2.5 linear metres. Orders for cut lengths less than 2.5 linear metres will incur a cutting and handling charge of £20 (plus VAT).

Payment Terms

Monthly Account 2.5% discount provided the amount due is paid by the 20th of the month following the date of despatch. Value Added Tax net. Unless we are responsible for a delay in invoicing, we cannot allow any settlement discounts beyond the periods specified above. Invoices not paid accordingly are deemed to be overdue and therefore strictly set.

Prices

All orders accepted subject to the conditions that prices charged will be those ruling at the time of despatch. Retail price applies only to orders for full uncut rolls.

Cancellations

Cancellations which must be confirmed in writing, can only be accepted prior to goods being cut or dispatched.

Returns

When goods are returned solely on the account of customer error, we will only issue credit amounting to that obtained for the goods on resale less 15% handling charge. In cases where goods returned are seriously damaged in transit due to inadequate packing or failure to roll the carpet as properly used (for scarp value only can be expected). Any carpet which is returned is at the customer's risk and should be clearly marked with the order's name and address.

Retention of Title

(a) So long as any money owing to the Seller from the Buyer is outstanding in respect of any goods sold subject to these conditions, the property in such goods delivered by the Seller to the Buyer or to the Buyer's order, will not pass but shall remain with the Seller until all such indebtedness has been discharged.

(b) You should be entitled to sell the goods referred to in paragraph (a) above in the normal course of business until the happening of any of the events referred to in paragraph (c) below but the proceeds of resale and/or the claim to such proceeds will be ours until such time as the total amount of the indebtedness to the Seller shall have been discharged.

(c) With regard to any of the goods mentioned in (a) or (b) hereof the authority of the Buyer to sell the goods shall be withdrawn (i) immediately on default in making a payment due under the contract, or

(ii) at any time after the commencement of any act or proceedings involving recovery of the goods or if the Seller shall reasonably consider that its property is in jeopardy and all goods in which the Seller has property shall be immediately delivered to the Seller and all proceeds of sale received by the Buyer from sales made prior to the withdrawal of authority shall be paid by the Buyer into a bank account separate from all other monies and shall be held in such account for the Seller. The Seller may (without prejudice to any other rights) recover or resale the goods and any of them and may enter upon premises of the Buyer by its servants and agents for that purpose.

Duplicate Orders

In the event of a telephone order or verbal order being duplicated due to failure on the part of the customer to mark the cut length on order as such credit will be admissible only within the terms stated above, under the heading 'Returns'.

Acknowledgments

Order acknowledgments should be checked on receipt as amendments cannot be made after the goods have been cut or dispatched.

Sizes and Specifications

It must be noted that slight variations in size are sometimes unavoidable and the Company will be deemed to have fulfilled its contract if sizes are within the British Standards Institute tolerance of plus or minus 1.25%. The Company reserve the right to alter constructions and materials without prior notice; in doing so, the Company also state that any changes will result in a quality of an equally high or improved standard. Whilst every effort is made, no guarantee can be given that any sample will conform exactly with the carpets supplied.

Damage or Loss in Transit

Claims for damage can only be considered if notification is received within 7 days of delivery (28 days if internal carriage to full roll). Claims for suspected loss must be lodged within 28 days from the date of invoice.

Complaints/Claims

All goods should be inspected by dealer prior to installation as claims resulting from visible defects cannot be entertained after the carpet has been cut or fitted. Any complaint that arises on goods already fitted can only be considered once the installation has been inspected by dealer and the details submitted on our official complaints form, a copy of which will be supplied on request. We can accept no liability for consequential loss or damage nor due to circumstances beyond our control or that of our suppliers.

Deliveries

Anticipated delivery dates are given in good faith and whilst every effort is made to ensure they are met this cannot be considered as the essence of any contract. Therefore on the rare occasion that a delay does occur we are not able to accept liability in the event of any corresponding claim.
