Option 1

Lounge, study, dining room 6 bedrooms, 2 dressing rooms

To supply 100% polypropylene Stainfree Twist – Corona (sample to follow)

Fitted on 10m PU foam Underlay

Smoothedge Gripper fixings stuck to concrete sub floor and pinned to wooden areas

Polished Aluminium door bars at doorways

Carpets fitted as a whipped runner on 1st flight of stairs

Chrome home pride stair rods supplied & fitted to 1st flight

Labour to install above materials

Total cost of all above labour & materials £3560.00 + vat @ 20%

Additional Cost

Airing cupboard & storage cupboard on top floor

Cut carpet net onto floor without underlay & gripper to both areas

Total cost of all above labour & materials £145.00 + vat @ 20%

Option 2

Lounge, study, dining room 6 bedrooms, 2 dressing rooms

To supply 100% polypropylene Obsession Saxony – 734 Ashes or 114 White Orchid (sample to follow)

Fitted on 10m PU foam Underlay

Smoothedge Gripper fixings stuck to concrete sub floor and pinned to wooden areas

Polished Aluminium door bars at doorways

Carpets fitted as a whipped runner on 1st flight of stairs

Chrome home pride stair rods supplied & fitted to 1st flight

Labour to install above materials

Total cost of all above labour & materials £4720.00 + vat @ 20%

Airing cupboard & storage cupboard on top floor

Cut carpet net onto floor without underlay & gripper to both areas

Total cost of all above labour & materials £262.00 + vat @ 20%
