Customer Notes

- Lounge – Quadrant at base of rear patio doors needs to be removed for neat finish. We would recommend the electrical socket is removed and the floor replaced as the socket will be felt under the underlay if not removed. TV & stereo to be disconnected before our arrival to site.
- Bedrooms – If wardrobes are required to be fitted from waste then the floor needs to be emptied and the lower clothes removed for fitter's access.
- HSL – There is a seam on the landing approximately 2.5m from bathroom door. Carpet will be finished at the family bathroom door as existing due to existing door bar being fitted under the bathroom tiles.
- Furniture – We will undertake to move large items of furniture but all small and personal items (especially delicate or valuable items) need to be removed from the areas where we are installing carpets prior to our arrival to site. Bed linen needs to be removed and any cupboards where carpets are to be fitted need to be cleared and clothes hanging close to the floor need to be removed.
- Doors – Please note our fitters do not cut doors. When the final carpet selection has been made a total clearance can be advised for customers builders to cut any doors that will not clear the new carpets.

Payment terms:

50% deposit required with order and balance is due 48 hrs before installation or 30 days after ordering if fitting is delayed at customers request.

Delivery

14-21 days required for ordering.

I trust this estimate meets with your approval and it is guaranteed for a period of 21 days from the above date. Thereafter it may be subject to change without notification if a manufacturer's price increase prevails.
