To supply Danube, 100% Synthetic carpeting, 5 metre wide, Colour: DAN/752P,
Luxury PU Foam underlay & Paperfelt Interliner to be laid beneath,
Fitting to same by gripperods installation,
Supply & fit standard aluminium doorbars at doorways,
Seam carpet between reception room & hallway & at 2 locations in hallway as necessary,
Move furniture as necessary (**Tenant/Customer must move small items / personal belongings**),
Uplift & dispose of the existing stuck down Coir floorcovering.

Please Note

Door trimming – It is often necessary to have doors trimmed prior to new carpets being installed. Our fitters do not trim doors; however we are able to recommend a private contractor who can carry out this work for an additional fee payable directly. (4 doors may require easing at this property).

Furniture Moving – It is the responsibility of the customer to clear all personal effects, breakables, movable items of furniture, computer and home entertainment equipment from the areas to be carpeted prior to our fitter's arrival.

Plaster Skirtings – It is not uncommon for flats in Kenilworth Court to have plaster skirting boards which are more delicate than wood skirting boards & therefore some minor damage can occur during the carpet laying procedure. Every effort will be made to minimise any damage, however we cannot accept any liability for cost of repairs should it prove necessary.
