Top floor 2 beds, Ground floor 2 beds, stairs & landings from top floor down to first floor

To supply Savoy 'Clearance', 100% Synthetic carpeting, 4 metre wide, Colour: Khaki, Homemaker Luxury 10mm PU foam underlay & Paperfelt to be laid beneath, Fitting to same by gripperods installation, Supply & fit 5 Satin Aluminium doorbars at doorways, Move furniture as necessary (**customer to move small items / personal belongings**), Uplift & dispose of existing carpets & underlay.

First flight of stairs & top riser from Ground floor to First floor

To supply Move, 100% Wool woven Wilton pinstripe carpeting, 70cm wide, Colour: 2006/51, Cut down to 60cm wide runner, Stairs to be fitted as 60cm wide runners with cotton tape sewn to both sides of runner, Tape Colour: C39 Slate (HB8467), (Approximately 55mm of tape showing on surface), Luxifelt combination crumb rubber/felt underlay to be laid beneath, Fitting to same by gripperods installation Supply & fit 70cm x 1.00m Coir matting Colour Natural into tiled matwell recess, Edging to matwell had not yet been installed by the tiler at the time of our site survey.

Please Note

Door trimming – It is often necessary to have doors trimmed prior to new carpets being installed. Our fitters do not trim doors; therefore please ensure all doors are trimmed to the correct height prior to the installation.

Furniture Moving – It is the responsibility of the customer to clear all personal effects, breakables, movable items of furniture, computer and home entertainment equipment from the areas to be carpeted prior to our fitter's arrival.
