**3 Steps from Kitchen to Snug, Stairs from Ground Floor down to & including Lower Ground Floor Lobby**

To supply Camel 'Clearance', 100% Wool carpeting, 4 metre wide, Colour: 190,  
Heavy Duty Rubber underlay to be laid beneath,  
Fitting to same, re-using existing gripperod fixings,  
Existing doorbars to remain at doorways,  
Areas to be clear of furniture at time of installation,  
All Stairs to be fitted full width,  
Uplift & dispose of existing carpets & underlay.

**Please Note**

**Stripe Direction** – As discussed & agreed during my site survey, in the lower areas the stripes will run down the steps towards the Playroom. Therefore, as the risers (vertical elements of the steps) run around the entire steps the stripes will in part be at 90° to the stripes on the tread (horizontal element of the steps).

**Door trimming** – The fitters do not trim doors, therefore please ensure all doors are trimmed to the correct height prior to the installation.
