**Stairs & Landings from ground floor to first floor**

To supply Rutland Twist '50' 80% Wool / 20% Synthetic carpeting, 4 metre wide, Colour: RUT50 N37, Heavy duty rubber underlay & Paperfelt to be laid beneath,

Fitting to same, re-using existing gripperrod fixings,

Supplement existing gripperrods where necessary,

Existing wooden thresholds to remain at all doorway connections,

Supply & fit 17mm PVC backed Coir matting Colour Natural at entrance lobby

Supply & fit 17mm PVC backed Coir matting Colour Natural to treads of first 2 steps (As existing)

Supply & fit aluminium A19 profile to edge coir mat at front door/entrance,

Uplift & disposal of the existing materials to be completed by others beforehand (gripperrods should be left in place as these will be re-used).

**Bathroom**

To supply Designatex Cushion Vinyl floor covering, 2 metre wide, Colour: 2146 Cornish Oak,

Supply & lay 3mm hardboard to prepare sub-floor,

Fitting to same by perimeter fix installation,

Supply & apply mastic sealant (White) to seal perimeters.

**Door Trimming** – The fitters do not trim doors, therefore please ensure all doors are trimmed to the correct height prior to the installation.
