Living Room, Hall & 2 Bedrooms (Inc. hall & Bed 2 cupboards)

To supply Hanoi, 100% Wool 'Stock Clearance' carpeting, 4 metre wide, Colour: 638/17, Homemaker Standard 8mm PU foam underlay to be laid beneath, Fitting to same, re-using existing gripperod fixings, Supply & fit 3 standard Aluminium doorbars at Living room & 2 bedroom doorways, Seam carpet at 2 cupboard doorways, Existing Coir Matting to remain in entrance lobby, Move furniture as necessary (**Tenant to clear all small items & personal belongings***), Uplift & dispose of existing carpets & underlay as necessary

Please Note

Door trimming – It is often necessary to have doors trimmed prior to new carpets being installed. Our fitters do not trim doors; however we are able to recommend a private contractor who can carry out this work for an additional fee payable directly if required.

Furniture Moving – It is the responsibility of the tenant to clear all personal effects, breakables, movable items of furniture, computer & home entertainment equipment from the areas to be carpeted prior to our fitter's arrival. Furthermore due to the basic quality of the furniture in the property we will require all wardrobes & bookcases to be emptied of their contents by the tenant prior to the carpet fitting – **Please ensure this is re-iterated to the tenant before the installation date.**

Moths – There is some evidence of **moth infestation** in the existing carpets, however the tenant assured us that the damage was historic & had already been treated. If you believe this NOT to be the case please advise us ASAP as Moth infested carpet & underlay cannot be loaded onto the fitter's vans for disposal as it presents a high risk of cross contamination.
