**Door trimming** – The fitters do not trim doors, therefore please ensure all doors are trimmed to the correct height prior to the installation.

**Furniture Moving** – It is the responsibility of the customer to clear all personal effects, breakables, movable items of furniture, computer and home entertainment equipment from the areas to be carpeted prior to our fitter's arrival.

**Uplift** – Due to the existing **moth infestation** the uplifted carpet & underlay can not be loaded on to the fitter's van to dispose of as this presents a high risk of cross contamination.
