**5 Bedrooms & Dressing Room**

To supply Pentillie 100% Synthetic velvet pile carpeting, 4 & 5 metre wide, Colour: PEN-107, Homemaker Luxury 10mm PU foam underlay & Paperfelt to be laid beneath, Fitting to same, re-using existing gripperod fixings, Supplement existing gripperods where necessary, Supply & fit 4 x Satin Aluminium doorbars at doorways (to 2 Loft Rooms, Loft Bathroom & 1<sup>st</sup> Floor Small Rear Room), Existing wooden thresholds to remain at all other doorways, Seam carpet to 1<sup>st</sup> Floor Front Bedroom recesses as necessary (as room is wider than 5 metres), Move furniture as necessary (**customer to move small items / personal belongings**), Uplift & dispose of existing carpets & underlay.

**Stairs & landings from top floor to ground floor**

To supply Havana 50% Wool / 50% Synthetic two-tone loop pile carpeting, 5 metre wide, Colour: HAV-21, Homemaker Luxury 10mm PU foam underlay & Paperfelt to be laid beneath, Fitting to same, re-using existing gripperod fixings, Supplement existing gripperods where necessary, Existing wooden thresholds to remain at all other doorways, Seam carpet to first floor front bedroom recesses as necessary, (room is wider than 5.00m) Move furniture as necessary (**customer to move small items / personal belongings**), Uplift & dispose of existing carpets & underlay.

**Please Note**

**Furniture Moving** – As discussed, the installation has been phased so as to allow you (the customer) to clear all personal effects, breakables, movable items of furniture, computer and home entertainment equipment from the areas to be carpeted prior to our fitter's arrival. Larger items such as beds, chests of drawers & wardrobes must be cleared of bedding & emptied of items so they can be manoeuvred successfully by the carpet fitters to accommodate the carpets installation. Failure to do so may result in the installation requiring more time than has been allocated, as we are in a particularly busy period this could result in a lengthy delay until these areas can be finished off.

**Door trimming** – Our fitters do not trim doors therefore please ensure that all doors have sufficient clearance prior to the installation.
