These general conditions of sale and delivery were deposited with the Chamber of Commerce and Industries at Arnhem. The following text is also effective and applicable.

ARTICLE 1: GENERAL

These general conditions are an integral part of all agreements and offers to be entered, unless explicitly otherwise stated by us in writing. All offers are free of obligation. Applicability of buyer's general conditions is hereby explicitly excluded.

ARTICLE 2: PRICES

Prices can be increased by higher costs resulting from measures taken by public authorities. We are, besides normal price adjustments, also entitled to change prices if changed market prices and/or price increases by our suppliers or other developments occur. Supplier shall inform the customer of any price adjustment as soon as possible.

ARTICLE 3: DELIVERY

Goods will be delivered ex works, unless otherwise agreed. Delivery shall be effected in conformity of the incoterms.

ARTICLE 4: DELIVERY TIME

Time of delivery stated on the order confirmation is a target and shall be considered flexible within reasonable boundaries.

ARTICLE 5: FORCE MAJEURE

If delivery does not take place in time (within a month around the stated delivery time) due to force majeure, either party shall have the right to suspend performance of the agreement or to terminate the agreement in full or in part.

ARTICLE 6: PAYMENT

Unless explicitly otherwise agreed upon, payment shall be effected in time and the money must be available on the bank account stated on our invoice. The bank charges for payment are for the account of the buyer. In case that buyer does not pay in time, the buyer owes interest charges of 1,5% per month from the date the amount is overdue as stated on the invoice. The juridical cashing and lawyers expenses, are for account of the buyer.

ARTICLE 7: RESERVATION OF OWNERSHIP

We reserve the ownership of all goods delivered by us until there has been paid for, in full. Buyer shall be obliged to hold the goods delivered under reservation of ownership as recognisable and identifiable goods from Ted Baker by Brink & Campman.

ARTICLE 8: SUSPENSION AND TERMINATION

If buyer does not, or not timely, fulfil any obligation arising under the agreement, we shall have the right to suspend (further) performance of all agreements entered and/or terminate the agreement(s) directly or the part thereof which is not performed. We reserve the right at all times to deliver goods after receipt of payment if we deem such advisable or necessary.

ARTICLE 9: COMPLAINTS

If it is clear that we are liable for defects in goods delivered, we can take back, replace or repair the goods. Complaints about apparently defects shall be reported in writing to us (and our agent or distributor) within fourteen days from receipt of the goods. Complaints about hidden defects shall be reported in writing to us (and our agent or distributor) without delay at the moment when they occur. The value of the goods will be written off in three years to zero. Slight deviations in quality, dimension, colours, finish and shading which are common in the industry and/or technically unavoidable, shall not give any ground for complaints.

ARTICLE 10: EXCLUSION OF LIABILITY

We shall not be obliged to pay compensation for any damage to business operations or any other damage suffered or to be suffered as a result of delayed or defective delivery or defects in goods delivered.

ARTICLE 11: PRODUCT LIABILITY

Buyer shall indemnify us against all claims from third parties.

ARTICLE 12: APPLICABLE LAW AND COMPETENT COURT

Dutch law is applicable to all agreements entered. All disputes shall be exclusively submitted to the court of Amsterdam.
