

# ADDITIONAL INFORMATION

## Prices

All prices charged to customers are based on the square metre price.

Net buying prices exclude VAT which will be charged at the rate ruling at date of invoice.

## Order Cancellation

Cancellations will only be accepted with the express permission of Brintons. Permission will only be given where the customer agrees to pay a cancellation charge equal to 75% of the net goods value due to the associated costs of cutting, wrapping and storage. Cancellations will not be agreed where the width of the carpet exceeds its length. Or the carpet has been cut into following dispatch.

## QuickWeave

All QuickWeave orders require a 50% deposit prior to processing, this is non-refundable. We are unable to cancel QuickWeave orders or make change after the deposit has been received.

## Non Standard Delivery Address

Brintons may, at its option, agree to deliver the goods to an address other than the address at which the customer carries on business but, if it does so, it shall be entitled to charge the customer a sum equal to the cost of delivery and an administration charge or £75 whichever is greater. No deliveries will be made to private addresses. Written confirmation must be provided prior to this being agreed.

## Failed Deliveries

If an attempt is made to deliver goods to an agreed address and there is not a justifiable reason for the failure of the delivery on the part of the customer then we reserve the right to charge the customer a sum equal to the attempted cost of delivery and an administration charge or £75 whichever is greater.

## Failed Collection of Returns

If an attempt is made to collect goods from a customer for return to Brintons after the customer has signed a faxback stating that the goods are ready to collect, suitably wrapped and rolled on a tube, we reserve the right to charge the customer a sum equal to the cost of the attempted collection and an administration charge or £75 whichever is greater.

## Deliveries outside Standard Service

Delivery requests that do not fall within our standard delivery terms will be quoted for on a separate basis.

## Order Acknowledgements

All orders are acknowledged to the customer. Please check all details are correct and advise our sales office of any discrepancy within 2 hours of order placement, as orders cannot be cancelled or amended after this time without incurring charges.

## Patterns & Samples

Patterns that are charged are non-returnable. Where samples are supplied free of charge, lost or replacement samples may be charged.

## Pattern Match

When estimating for patterned carpets please order sufficient material to fulfill critical pattern match requirements.

## Flammability

All qualities stated on this price list when tested according to BS 4790 have a low radius of effects of ignition (up to 35mm) and a pass for BS 6307. Further information on C€ flammability available on request.

## Shading

Brintons' guarantee against random shading as published on [www.brintons.co.uk](http://www.brintons.co.uk) and subject to the limitations and/or exclusions published on [www.brintons.co.uk/brinset](http://www.brintons.co.uk/brinset).

## Berber and Colour match

This carpet is produced from a wool-rich yarn blend. Heather and Berber effects are created by blending different coloured wool which can appear as dark flecks or linear forms in the carpet. This is considered an attractive and intentional feature. As all natural textiles have colour and blend variances between batches, an exact match to sampling is not guaranteed and manufacturing tolerances will apply.

## Warranty

Brintons will make good, or at our discretion replace carpet with an equivalent alternative, any carpet found to have manufacturing defects within two years of Brintons invoice. This warranty excludes excessive wear and tear and installation errors.

## Fitted Complaints

If no supplier's fault is identified following an inspection a £75 charge will be applied.

## Pre-Installation Complaints

If no supplier's fault is identified following the return of a carpet, a 75% handling/ re-stocking charge will be applied. If the account requires the carpet to be returned, due to this above outcome, this must be requested in writing within 7 days. After this time the carpet will be unavailable and charges payable.

## Installation

This product must be installed using good quality underlay and by professional installers in accordance with BS 5325 or the NICF manual.

Brintons operates a quality management system in accordance with ISO 9001:2015 Quality Assurance Standard and an environmental management system in accordance with ISO 14001:2015 Environmental Assurance Standard.

Brintons work in accordance with the Carpet Foundation Code of Practice.

Brintons woven carpet is made at its own manufacturing plants in Poland, Portugal or India.
