

ADDITIONAL INFORMATION

Prices

All prices charged to customers are based on the square metre price. Net buying prices exclude VAT which will be charged at the rate ruling at date of invoice.

Cancellation Charges

The following charges will be applied on order cancellation:

1. An order received but not processed – no charge
2. A processed order neither cut or wrapped – administration charge of £50
3. Orders cut or wrapped – 10% of the NGV, minimum £100 charge
4. Orders cut, wrapped or loaded – 15% of the NGV, minimum £150 charge
5. Orders despatched – 25% of the NGV, minimum £250 charge

Please note:

Orders delivered where the carpet length is less than the width will not be accepted as a return and will be charged in full. Items 2, 3 and 4 will be invoiced separately. Item 5 will have the invoiced amount adjusted when cancelled orders are credited.

Non Standard Delivery Address

Brintons may, at its option, agree to deliver the goods to an address other than the address at which the customer carries on business but, if it does so, it shall be entitled to charge the customer a sum equal to the cost of delivery and an administration charge or £75 whichever is greater. No deliveries will be made to private addresses.

Failed Deliveries

If an attempt is made to deliver goods to an agreed address and there is not a justifiable reason for the failure of the delivery on the part of the customer then we reserve the right to charge the customer a sum equal to the attempted cost of delivery and an administration charge or £75 whichever is greater.

Failed Collection of Returns

If an attempt is made to collect goods from a customer for return to Brintons after the customer has signed a faxback stating that the goods are ready to collect, suitably wrapped and rolled on a tube, we reserve the right to charge the customer a sum equal to the cost of the attempted collection and an administration charge or £75 whichever is greater.

Deliveries Outside Standard Service

Delivery requests that do not fall within our standard delivery terms will be quoted for on a separate basis.

Order Acknowledgements

All orders are acknowledged to the customer. Please check all details are correct and advise our sales office of any discrepancy within 24 hours.

Patterns & Samples

Patterns that are charged are non-returnable. Where samples are supplied free of charge, lost or replacement samples may be charged.

Making Up Charges

A charge of £1.05 per linear metre (88p per linear yard) will be made for slitting to non standard widths. When joining body or broadloom widths, the following seaming charges will be made:- Cross joining & seaming of border material - £5.50 per linear metre (£4.62 per linear yard) of seam. Microseaming - £4.20 per linear metre (£3.53 per linear yard) of seam. Hand Binding - £10.00 per linear metre.

Pattern Match

When estimating for patterned carpet please order sufficient material to fulfil critical pattern match requirements.

Flammability

All qualities stated on this price list when tested according to BS 4790 have a low radius of effects of ignition (up to 35mm) and a pass for BS 6307. Further information on CE flammability classification available on request.

Shading

Is a natural phenomenon which occurs in cut pile carpets, and is not considered a manufacturing fault. It is caused by changes in pile direction and is visible as light and dark patches. Shading can be exaggerated by lighting and location. Permanent random shading or pile reversal in domestic installations which occurs away from traffic areas is covered by our two year Brinset guarantee.

Berber and Colour match

This carpet is produced from a wool-rich yarn blend. Heather and berber effects are created by blending different coloured wool which can appear as dark flecks or linear forms in the carpet. This is considered an attractive and intentional feature. As all natural textiles have colour and blend variances between batches, an exact match to sampling is not guaranteed and manufacturing tolerances will apply.

Warranty

Brintons will make good, or at our discretion replace carpet with an equivalent alternative, any carpet found to have manufacturing defects within two years of purchase. This warranty excludes excessive wear and tear and installation errors. All communications to pass through the retailer following their own inspection.

Fitted Complaints

If no supplier's fault is identified following an inspection a £75 charge will be applied.

Pre-Installation Complaints

If no supplier's fault is identified following an inspection a £75 handling/re-stocking charge will be applied.

Installation

This product must be installed using good quality underlay and by professional installers in accordance with BS 5325 or the NICF manual.

Brintons operates a quality management system in accordance with ISO 9001:2008 Quality Assurance Standard, and an environmental management system in accordance with ISO 14001:2004 Environmental Assurance Standard.

Brintons woven carpet is made at its own manufacturing plants in the UK, Portugal or India.

Brinfelt

Brinfelt is a 65oz, 2.3 tog combination felt and crumb rubber underlay manufactured in the UK. It is produced using our thread and yarn waste from our UK factories and we are actively reviewing all our waste streams for possible inclusion.
