GENERAL INFORMATION

BACKING

All Newhey Colortec and Tufted Graphics products are secondary backed with evobac as standard.

ROLL LENGTHS

Roll prices relates to orders over 25 linear metres of full 4m width material. For all orders falling below this, cut length pricing will be applied.

ROLL CUTS

Where full rolls are required to be split into cut lengths a charge of £15 per cut will be applied.

DELIVERY

Items in stock will generally be delivered within 3-5 working days from date of despatch, which is included within the pricing stated.

INSTALLATION

We recommended all carpet should be installed in accordance with BS 5325, the Code of Practice for the Installation of Textile Floor coverings. In public areas & corridors exceeding 6.50, in length, and/or two widths or more, we strongly recommend carpet is installed on a suitable contract quality double stick installation system. No claims can be made against the company for problems arising from imperfect fitting or the refitting of replacement carpets. For a comprehensive installation guide please contact the sales office.

CARE AND MAINTENANCE

Daily vacuuming and cleaning are essential as part of a general day to day maintenance programme. Appropriate and immediate spot cleaning of spillages is advised. For wet cleaning and in a commercial environment it is recommended a professional cleaning company are employed. TERMS OF TRADING

PRICES

Goods will be charged at prices ruling at date of order.

CARRIAGE

All prices quoted include our standard carriage service of 3 5 working days from date of despatch to mainland UK. Special delivery arrangements can be made by contacting our sales office. If your order is required more urgently please contact our sales office who will make every effort to meet your requirements. Additional costs may be incurred for special, date or time specific, night or phased deliveries.

DAMAGE IN TRANSIT

All carpet produced is subject to inspection prior to despatch. Upon receipt carpets should be inspected thoroughly as claims for damage will not be accepted once the goods have been cut and/or installed. All claims must be made in writing.

CLAIMS AND RETURNS

Carpets must be inspected before cutting. Claims for manufacturing faults or shortages cannot be accepted after carpet has been cut and/or installed. Returned goods will not be accepted unless prior written authorisation has been given by the company. Failure to comply with these conditional may result in goods not being accepted and returned to the customer at their expense. All returns must be packed in adequate wrapping material to protect from damage. Any damage incurred by improper wrapping will render any claim null and void.

SIZES

Whilst every effort is made to provide the correct size, slight variations are unavoidable. We recommend that you check roll sizes are correct prior to cutting. Claims for short measures cannot be accepted once the carpet has been cut. The British Standards Institute's tolerance is +1.25%. Clause 3 BS 3655 1974.

CANCELLATION AND REJECTION

Cut length orders cannot be cancelled once the carpet has been cut from stock and prepared for despatch.

COLOUR MATCHING

Whilst every effort is made in matching colours and shades, differences may occur between dyeings, pattern book samples and roll stock. Therefore samples should be used as a guide and not an exact colour match. Were it is necessary to have all carpet from the same colour batch this should be made clear in all correspondence at the time of order.

SHADING

Shading, and/or pile reversal, is a phenomenon that can occur in any cut pile carpet. Shading is an inherent characteristic. This tendency is not detrimental to the wearing properties of the carpet and is not due to any manufacturing fault. The company cannot therefore accept complaints arising from these effects.

V.A.T

V.A.T at the prevailing rate at the time of invoice is charged on all goods and carriage/sundries.

TERMS OF PAYMENT

All goods will be invoiced by Newhey Carpets Ltd., and all payments will be made to Newhey Carpets Ltd. Accounts Dept. Gordon Street, Newhey, Rochdale, Lancashire OL16 3SL. Standard payment terms, where credit accounts are in place, are strictly 30 days from date of invoice. Early settlement terms do not apply.

PASSING OF PROPERTY AND RISK

The risk in the goods shall pass from the seller to the buyer upon delivery of such goods to the buyer. However, notwithstanding delivery and passing of risk in the goods, title and property in the goods, including full legal and beneficial ownership, shall not pass to the buyer until the seller has received in cash or cleared funds payment in full for all goods delivered to the buyer under this and all other contracts between the seller and the buyer for which payment of the full price of goods thereunder has not been paid. Payment of the full price of the goods shall include the amount of any interest or other sum payable under the terms of this and all other contracts between the seller and the buyer under which the goods were delivered.
